# City of Bayfield Common Council Meeting Minutes of October 18, 2023, 5:30 p.m.

### Call to Order - Roll Call - Pledge of Allegiance

Mayor Ringberg called the meeting to order at 5:30 p.m. followed by roll call and the Pledge of Allegiance.

### Review/Approve Agenda

Kelly Westlund provided a verbal and written update on the PRO Housing Initiative project. She noted a public hearing has been scheduled at the Bayfield City Hall on Monday, October 30, 2023, from 8 – 10 a.m.

Bob Shunning, a resident of Bayfield, mentioned McCarthy Land that is for sale and the possibilities that could arise out of future City Ownership of that property (senior and workforce housing, City Hall). This property connects to property owned by AJ Long.

## 2. City of Bayfield Sidewalks - Snow Removal Request, Mark Bahr

The Council was informed snow removal was discussed at the last Public Works Committee Meeting. Mr. Bahr noted he understands there are no plans to do anything different during the 2023-2024 winter season. Discussion ensued. Mr. Bahr indicated he has some ideas about the situation, and he provided them to the Council for further consideration. No further action was taken.

Mayor Ringberg provided a summary of what has changed since the last meeting. Discussion ensued.

- Revenues are stated at 20%, which is a very conservative approach; 40% is more typical.
- The fee for the passes needs consideration; the \$10.00 fee for all, doesn't seem right for all parties.
- The new version has a 3-hour allowance for City Residents to park on Rittenhouse and Broad Street.
- Should parking revenues be restricted to road improvements? Councilor Bland provided a sample
- The parking plan indicates employees would be parking further from the downtown core area.
- The number of employees, their wages, and benefits and where they will be housed needs additional review. A work flow map was requested again. Are the employees stand alone? Or under the supervision of the PD?

### 4. Resolution 612 – Sewer Rate Increase of 3%

Carrier/Cornelius moved to approve Resolution #612 with the understanding the language would be changed so the rates would go into effect the first day after the meters are read in February 2024. Passed by roll call vote as follows: Bland, Carrier, Cornelius, and Dougherty – yes.

5. Consider Bayfield County TAP Grant Letter of Support Request

Carrier/Bland motioned to endorse having the Mayor send a letter of support as requested. Carried.

Resignations & Appointments:** Tom Kovachevich, PWD (Effective May 2024), Parks & Recreation Cornelius/Bland moved to accept with regret the retirement of Tom Kovachevich effective May 2024 after 33 years of service and to accept the Mayor's appointment of Peter Havlik to the City of Bayfield Parks and Recreation Committee. Carried.
- **7. 2024 Budget & CIPS:** The 2024 Budget was not available. The Council agreed to hold a special meeting on Wednesday, October 25, 2023. Fire Department members were present to discuss their overall request since they would be at another meeting on October 25, 2023.
