- Public Input on Agenda Items:
  - Jacob Kaiser—Concerns from Rec Center that membership will drop off in paid parking is put in place—would like protection for customers outside of Bayfield to visit and would like to see validation for merchants. Lived in Eagle River, WI where paid parking was implemented and then removed and fears it is too confusing for this small of an area.

**Agenda**

1). Finalization of Parking Management Plan:

- i. Chapter 2 contains information about the State of the City
- ii. Chapter 1 contains information about equity and having everyone pay for parking.
- iii. Completed Chapter 4 until further information from the public is taken in.
- iv. Chapter 7 removed the benefit district and lays out a standing committee to advocate for CIPs.
  - a. Does not mention adding more parking. Need more data before purchase is made—future CIP?
    - i. Add language that suggest investigating more parking.

**Discussion:** Map is not accurate and needs to be updated. Boat and trailer parking need to be looked at—can Harbor propose options when they look at the plan? DNR plays a factor in the boat ramp—lot on their land. Exception might need to be made about overnight parking—leave to discretion of enforcement? Make two blocks by the boat ramp long term parking? Make a general statement that suggest PMP is a work in progress. What will the zones be called? Advocation for premium/value system. Formatting needs to be worked on. Tables of rates should be left out of the plan but shown in the appendix. A clear copy of the rates should be given to all committees and the public. PR move to give to each of the committees—input from Public Works and Planning, but informational for the rest of the committees. Charge more for long term parking--\$20/ day.

**Motion by Halvorson to recommend the plan with minor changes to all committees for November meeting. Seconded by Cirillo. Carried.**
