## Agenda Item(s):

- Temporary Shelter Request: Radtke/Bland motioned to approve temporary shelter request for the Maritime Museum beginning May 1 – October 15, 2024, 12'x26' hoop frame with poly cover. Carried.
- 2. **Conditional Use Permit Application:** True North Sailing Charters, LLC application withdrawn. No action taken.
- 3. Wayfinding Signage Updates/Next Steps to finalize project: Bland gave a brief overview: Bob Durfey took up the challenge that the Plan Commission tasked him to do. The Plan Commission needs to make two decisions to move our vendors along.
  - 1. Where the 3 parking signs need to go. Fizell/Radtke motioned to approve Durfey, Bland and Public Works come up with the placement and orientation of the 3 parking signs. Carried.
  - 2. Butcher block maps to be set on brownstone and what is the process for selection and placement of the stones. Radtke/Fizell motioned to approve Durfey and Bland to select brownstone and work with Public Works on placement. Carried.

Bland continued his overview regarding restroom, pedestrian, icon, and directional signs which are all scheduled to be installed. The 2 main entry signs are going to be more challenging. The Commission at a future meeting can decide whether to proceed with those. Last are the facility signs which can also be decided whether to proceed at a future meeting.

Durfey recommended getting the restroom doors cleaned and painted and included as part of the project.

Bland and Durfey also recommended purchasing "All Gender" restroom signs. Radtke/Fizell motioned to approve Bland and Durfey to purchase and install the "All Gender" restroom signs and to repair and paint the restroom doors as needed. Carried.
