Bayfield Outdoor Recreation Plan Review Addendum January 5, 2023

In accordance with the City's Outdoor Recreation Plan (ORP), the Parks and Recreation Committee conducts its annual review of the plan in January to identify accomplishments and adjustments to the plan. The ORP will not be changed. After its adoption by the Committee at the January meeting, this addendum will be posted on the City's website as a public record and reference of the review. These annual reviews will be referenced when the ORP is updated in 2025- 2026. The Plan Implementation Table is also revised to incorporate new actions. A list of 2023 priorities has been derived from this table for the purpose of guiding the Committee's 2023 activities.

| 2021 | | East Dock Park | The construction company that is currently performing harbor improvements adjacent to the park has agreed to repair and renew the sand volleyball court that sits at the east end of the park. This facility was badly in need of rejuvenation. |

| 2022 | | Halvor Reiten Park | A new Dock L has been installed to replace the previous dock that was damaged by storms back in 2018. Additional riprap was placed around the dock as reinforcement. At present, the dock is accessed via natural foot path along the spit. This path will be monitored to determine if any other improvements are needed. |
