- Add the following sentence, "Amount of remuneration to be determined by the department head and based on the available budget."
- Consider language that requires successful completion and define what that means.
- Consider a 50% match, up to \$5,250. This figure is based on the maximum tuition benefit expenditures exempted from withholding tax.
- We ask the Council to review the attached article. It is dated yet limits appear unchanged since 2014.
